Update on Development Application Layout

Thank you for your time earlier this week where we tabled and discussed our revised Solar Farm and Substation concept which is reduced in scale to a maximum of 150MW energy generation.

I have summarised the key points raised during our discussion:

- The revised concept was informed by further specialist studies and following feedback on specific issues (including but not limited to, proximity to boundaries, visual impact, rural land use, waterways and hydrology) received primarily from neighbour's and other community members.
- Removal of array sections from the western, southwestern and northern portions of the site. Significant increased setbacks to arrays from southern and eastern interfaces. Both measures will preserve the rural and landscape character of the site.
- Waterways have been considered in the redesign, with setbacks in most instances far exceeding those prescribed by the planning scheme.
- Perimeter vegetation screening and permeability for cattle has been incorporated into the concept design.
- Upfront works to Burgess Road would be undertaken while the analysis of the intersection of Blackmans Gap Road and the Bruce Highway are ongoing.



- The fire and hazard dispersion modeling demonstrated that the area of any impact was local to the array and contained well within the array area and away from boundaries.
- The re-design considered both Councils planning controls including overlays, and the Draft State Code 26.

Notice under Chapter 3, Part 2, Div 2, Sect 52 (1) of the Planning Act 2016

Due to several factors, including the significant changes made to the layout and the imminent upcoming change to the planning assessment regime in Queensland for solar farms, the current application would need to revert to the beginning of the application process.

In this respect, this correspondence constitutes the required notice under the *Planning Act 2016* (Chapter 3, Part 2, Div 2, Sect 52(1)), formally withdrawing Development Application DA/32/2024. An emailed copy of correspondence notifying referral agencies of such is enclosed for your information.

Other relevant matters

We are liaising with the Commonwealth regarding the project's *Environmental Protection and Biodiversity Conservation Act 1999* (EPBC Act) referral, as the proposed changes to the project are significant. Such may warrant a new determination due to the reduced development footprint and corresponding reduced impacts.

The recently completed further specialist studies and design work will form part of a new application (ultimately made to the State Government) following any future Social Impact Assessment (SIA) and Community Benefit Agreement (CBA) process undertaken with the Gladstone Regional Council.

The extensive consultation we have undertaken to date regarding our Community Partnership and Neighbour programs will assist greatly in informing any future SIA & CBA with Council.
